## • Presentation: Clemson Ombudsman: Tessa Byer

- The purpose of the Ombuds office is to provide a safe space for members of the Clemson community to share concerns.
- Coaching, helping to figure out options, referral to next steps
- o Goal: create global change in Clemson to proactively prevent conflict
- Standards of practice: Neutral 3 party, always informal, independent department, confidential.

### **Approval of Minutes**

- Faith Isreal distributed the March 16, 2022, meeting minutes via email to all members, and asked if there were any questions.
- Motion made by Brian Beer to accept the minutes.
- Seconded by Chad Carter.
- Vote passed to accept the minutes.

#### **Old Business**

- Resolution chart
  - o Faith shared her story about pre-knowledge of Senate and her experience in various roles. She desires to have a system in place for new hires who are unfamiliar with Extension Senate. Faith shared updated resolution chart: Liaison is the only new element added to chart from previous years flow of concern. Faith mentioned that input was taken from last meeting and now concerns can be shared online as an alternative in "share your concerns" tab. Faith thanked Charley for the idea of online form. Online forms be shared directly with their region Senator and executive committee. Faith shared "members" tab.
- Senate president shares at ELT meetings with all program team leaders, district directors,
  & field ops leaders.
  - Faith gave an update from meeting: Sign in sheets update: ethnicity and name can't be combined on a shared document.
- Brian Beer asked a question about previous concern getting stalled, and not everything needing a resolution. He likes that the updated chart allows Senate body to push an issue forward.
- Chad Charter asked for a motion to be amended for the executive Senate box to be removed from flow chart. He recommends Senators to bring issue directly to open Senate and request to be added to agenda.
  - Chase Ballie stated that box be edited not removed.
- Charley Maxwell is worried future president would be gate keeper and requests that the chart defined in constitution to avoid future issues.
- Move to amend box to say "notification to be added to meeting agenda".
- Mallory mentioned that updated chart helps to organize concerns.
- Mark mentioned editing box to read easier but that is needed to help keep concerns organized.
  - o Chad mentioned that his concern is that executive committee box is not defined.
  - Chad withdrew his motion to edit box.
  - Brian makes a motion to state that exec committee is contacted to add item to agenda.
  - Chad seconded motion.

- o Jason asked for approval of motion. No nays, all members in agreement.
- o Jason recommended that we seek approval of amended resolution chart.
- o Charley moves to adopt resolution chart as policy, Mallory seconded.
- o Jason asked members to adopt resolution chart as policy. None opposed.

#### **New Business**

- Weatherly asked how a new Senator would find old minutes/resolutions.
  - Mallory mentioned that past Senator could inform/update new Senators on extension Senate. She also mentioned Extension Senate being added to Onboarding.
  - Faith stated she will try to update web site to help new Senators navigate their roles and stay informed.
  - Susan Lunt stated having a mentoring Senator to help new members.
    Create a checklist for new Senators.
  - Chad brought up an actual Senate Onboarding/ new Senator orientation prior to our first Senate meeting. Crash course on parliamentary procedure, updating members.
- Mark Cathcart, alternates typically don't come but maybe they should be invited to all open Senate meetings as non-voting members to stay informed in case they need to vote in the future.
- Faith shared committee summaries from constitution.
- Faith asked what recommendations we have for Clemson's Onboarding process. Mallory mentions that Senate members get more involved and have more of a role in Onboarding topics.
  - Faith compiled a drafted list of topics that Senate members felt needed more attention during Onboarding:

- -P-Card Training
- -HR benefits checklist
- -Account Breakdown

  - Community resources
  - County council

- Janine requested Faith to send this out to entire Senate members and get feedback for next meeting. Mallory agreed and suggests to make it a Qualtrics survey.
- Faith mentioned two surveys will be released in the future:
  - Awareness committee survey to come out.
  - Onboarding issues survey to come out.
- Faith future meetings will be scheduled as needed. If nothing comes up, we will meet again at president's meeting at end of the year.
