What is the In-Place Recycling Conference?

The In-Place Recycling Conference is a Southeastern States regional forum of pavement professionals representing State Agencies, Contractors, Suppliers, Consultants, Academia, Local, MPO's and Federal Government Officials, all working together to take advantage of the synergy to be gained from sharing information and identifying common issues for further investigation.
