

### **Course Description:**

This introductory course in Art is designed for the non-art major for the purpose of understanding of the world of Visual Arts. Emphasis will be on the analysis of formal and conceptual basis for artworks within the context in which they were made. This course will move from lecture and discussion, to experientially based learning to accomplish objectives.





### **Student Learning Outcomes:**

- Identify major periods, styles, and works of art and how they relate to the culture and time they were derived from.
- Develop skills and vocabulary to analyze, interpret, and compare and contrast artworks.
- Develop an understanding of the context with which artwork, artists, and periods are shaped by their times: social, cultural, and political influences within an historical context.
- Develop the ability to assemble information relevant to a significant, complex issue, evaluate the quality and utility of the information, and use the outcome of the analysis to reach a logical conclusion about the issue.





#### **Course Methodology**

Course objectives will be realized primarily through discussion, assignments, research, and presentations.

#### **Student Responsibilities:**

- Research areas of interest beyond what is presented in class in order to effectively contribute to the class discussion.
- Keep an open mind and learn to appreciate the diversity and range of artwork produced throughout human history.
- Most importantly: Ask questions, turn in work on time, and participate in class discussion





#### **Evaluation:**

Grades will be given for each assignment. Grades will be determined based on depth of research and quality of material presented. Participation during class discussions is also expected. Your opinion is valuable to the growth of others. There are five graded assignment areas that are equally weighted: Responses, Quizzes, CCA Assignment, Studio Art Project, and Final Exam.

**Responses** are analytical research on material presented in class, responses will be in the format of Google Slides. Responses are an investigation into an artist, art movement, or artwork of interest to you. You will be presenting your work in class in a group discussion format on an assigned day.


**Quizzes** are short papers on an assigned topic, number of quizzes is usually two. The CCA assignment is similar to a quiz, with the expectation of more in depth research.

The **studio art project** is designed to demonstrate your understanding of Art, and does not require prior studio art experience or expensive materials to complete.

**Exam**: Students with an "A" average for the semester are exempt. The university assigned exam time for this section of ART 2100: Thursday April 29 from 8-10:30AM.

### Grading Scale:

Grades will be given as letter grades with (+) or (-) as needed. At my discretion grades may be given as pass/fail with the option of re-submitting work until it is satisfactory. Late work is never graded on a pass/fail basis with no option to re-submit. Your level of class participation is factored into each area.





### **Turning in Work: Google Drive & Canvas**

I will share a Google Drive folder with the class. I will upload presentations after class into this folder. Google Slides is the best format for class presentations. A .pdf or .jpg file will be the preferred formats for other assignments: *However I'm flexible on file format as long as I can view it.* 

Assignments will be turned in through Canvas. Class presentations *also* need to be turned in through *both* Canvas and the Google Drive folder.





#### Attendance:

- COVID-19 implies flexibility however attendance policies are in effect again this semester.
- Attendance is mandatory for <u>all</u> classes including those that you may not be presenting for or be directly involved in.
- A missed presentation <u>will</u> result in automatic failure (F) of that assigned presentation section.
- 3 unexcused absences is the limit before your grade is affected.
- 4th unexcused / undocumented absences <u>will</u> lower the final grade one letter. Each additional absence will result in an additional letter grade drop.
- Notification of Absence Necessary absences related to other University activities must be documented <u>prior to</u> the date of intended absence. Student will make arrangements with the professor to make up missed work.





#### **Excused Absences:**

- Notification of Absence: Best practice is to notify the instructor prior to missing any class in order to qualify for an excused absence.
- This must be followed up by turning in a note upon returning to class documenting the reason for your absence. Determination of whether your absence is excused or not will then be made.
- Necessary absences related to other University activities must be documented <u>prior to</u> the date of the intended absence. Students will make arrangements with the professor to make up missed work.
- Work and class time missed during an excused absence must be made up or the Excused Absence will revert to Unexcused.





#### **Classroom Conduct**

Appropriate academic conduct means maintaining a safe learning environment based on mutual respect and civility. Materials presented and resulting discussions may at times be controversial. Artwork presented and resulting discussions will bring up topics and imagery on: race, sex, religion, politics, gender, power, etc. All participants in Clemson courses are expected to behave professionally by adhering to these standards of conduct:

- Understand that Art is a very broadly ranging subject and that Artworks often have different interpretations for a variety of reasons.
- Respect other people's privacy as well as your own.
- Forgive other people's mistakes.

- Express your position without attacking others holding differing positions.
- Feel free to contact me with any concerns.





#### **Zoom Etiquette:**

- Keep your microphone muted when not needed to eliminate background noise for everyone.
- Feel free to unmute your microphone anytime you need to ask a question. Class is discussion based and you need to participate.
- Chat can also be used to ask a question.
- Everyone should have video enabled, and your attention should be with the class.
- Attend class from a location with a decent internet connection.
- Join the zoom meeting on time.
- Make sure to use your name in your Zoom profile.





#### Specific COVID-19 related information for in-person classes:

Engaging in dialogue with our guests by asking questions is also highly recommended.

#### **Catalog Description:**

One-semester lecture survey that introduces the nonmajor to an overview of art and architecture from different time periods and cultures. Students are encouraged to appreciate the contribution to Art made by the great masters and to discern different styles, art techniques, and creative traditions.





### **Critical Thinking**

Students will learn critical thinking skills through class discussion and coursework in ART 2100. Students will develop their critical thinking skills by communicating and presenting ideas and positions while interpreting Art within the context of a contemporary worldview. This ART 2100 course has been developed with <u>CT2 (Clemson Thinks2)</u>. Critical Thinking students will:

- Explore complex challenges
- Analyze multi-dimensional problems
- Extrapolate from one conceptual context to others
- Synthesize alternative solutions to multi-dimensional challenges
- Communicate effectively, complex ideas

Critical Thinking can further be defined as a cognitive manner of interpretation paired with analysis. You will be challenged to uncover your own biases and assess your thinking methodology. Art is a wonderful subject material to investigate open ended questions and your own thought processes. You will also produce a studio art project that embodies critical thinking through visual communication. By applying Critical Thinking to the study of Art, you will learn how to apply CT to other disciplines.





#### **Cross-Cultural Awareness**

ART 2100 is designed to fulfill Art & Humanities (Non-Literature) general education and Cross-Cultural Awareness requirements set forth by Clemson University.

- This course falls into the category of Arts and Humanities because we will be cultivating and understanding of the history of art, and examining how art and architecture serves as documents and expressions of history, world cultures, and the human experience.
- This course demonstrates cross-cultural awareness because students will analyze and critically compare the art and architectural developments in world cultures with respect to one another as well as historical and contemporary perspectives.
- A CCA assignment will need to be completed.





#### **Arts and Humanities Non-Literature**

ART 2100 satisfies requirements for Cross Cultural Awareness and Arts and Humanities Non-Literature simultaneously. ART 2100 analyzes and interprets the arts and humanities through the global history of Visual Arts.

#### Evacuation:

- When evacuating buildings, do not use elevators as they may lose power, stranding riders.
- Familiarize yourself with the locations of stairwells and exits.
- Individuals needing assistance evacuating should move to a stairwell away from the hazard, dial 911, and provide the Dispatcher with their exact location and what they need regarding evacuation.
- When evacuating follow the instructions provided by Public Safety personnel to reach a safe place.
- To seek "Tornado Safer Places," get to the lowest level of the building time allows, stay away from areas with windows and glass, and put as many walls as you can between yourself and the outside. In public buildings, bathrooms typically have an additional wall.

#### **Active Shooter:**

- Always call 911 as soon as you possibly can.
- Run away from the area, if it is safe to do so, time allows and the gunman is not nearby.
- Hide if the gunman is too close to your location. Find a safer place, lock and barricade doors, turn the lights out, and cell phones off or to vibrate.
- Fight. As a last resort, resolve to fight the intruder with everything you have at your disposal.
