Limits:

Qualifications:

Candidate must:

1. Have been active Fall 2020 or Spring 2021 semester.
2. Have been classified a senior either Fall 2020 or Spring 2021 semester.
3. Have an overall GPA of 3.0 or better at the time of nomination.

Evaluation:

- Application shall be evaluated by a committee according to the attached point assignment.
