COURSE MODALITY: Hybrid

Course Description

This is a 1-credit seminar course. In this course, student will learn the fundamental principles of computer and network security and privacy by studying attacks on computer systems, network, and the Web. The focused areas include applied cryptography, cloud computing, IoT, security and privacy in social networks, health system, and wireless networks. This course mainly consists of lectures, seminars, discussions, and course project.

Course Objectives

The primary goal of the class is to expose students to cutting edge research and prepare them for conducting research independently. By reading and analyzing research papers recently published in prestigious international conferences and academic journals, the students are expected to construct a big picture of the focuses and trends in the network security area, master skills of learning through literatures, and develop the corresponding research capability.

Required Materials

The course material will be papers from top journals and conferences.

Topical Outline

This can be organized by weeks (15 weeks for fall/spring semesters) or hours (3 hours per credit hour).

1. Overview of Network Security Problems (1 hour)
2. Introduction to Cryptography (2-3 hours)
3. Security and Privacy in Cloud Computing (2 hours)

4. Security and Privacy in IoT (2 hours)
5. User authentication in Mobile Systems (2 hours)
6. Machine Learning Security and Privacy (2 hours)
7. Security and Privacy in eHealth/mHealth System (1 hour)
8. Security and Privacy in Wireless Networks, including Location-based Service, Wireless sensor networks, WiFi, etc. (1-2 hours)
9. Blockchain/Web Security (1 hour)

Attendance Policy (Hybrid classes)

1. A statement about the hybrid process that explains that the university will assign students a day of the week they are to come this class; on other days, they must attend online.
2. A statement about whether attendance is mandatory or optional on days students are to come physically. Note that the university strongly discourages mandatory physical attendance requirements.
