

## ECE 8030: Computing Frontiers Section 001 FALL 2020

COURSE MODALITY: HYBRID

**COURSE DESCRIPTION:** Emerging and potentially disruptive computing architectures, methods, etc., in the literature are introduced. In addition, best practices in research, literature reviews, and technical speaking are presented. Current articles and papers on computing architecture are reviewed and discussed.

## COURSE PREREQUISITES: None

**STUDENT LEARNING OUTCOMES:** Students will be able to conduct focused literature reviews, read current literature from a critical and technical perspective, formulate a technical summary of a paper, develop and present a technical presentation, and better understand the publication process.

**REQUIRED MATERIALS:** No required text. Students are required to have a laptop computer, internet connectivity capable of transmitting and receiving video, a video camera, a microphone, and a cell phone.

TOPICAL OUTLINE: Each week in class, time will be spent reviewing one or more papers on computing architecture and related topics from the current literature (within past 3 years and a minimum of 8 pages from Journals or top-tier conferences such as IEEE or ACM). Each student is expected to participate in class discussions and present one or more literature reviews.

- Week 1 Course overview, discussion of literature review process, criteria for selected papers, rubric for presentation assessment, and discussion of topic areas for the semester.
- Week 2 Sample presentation from current PhD student, overview of some sample papers, discussion of paper selection and approval process for each week.
- Week 3-15 Students will rotate selecting and presenting an instructor approved paper (one per week). Other students in the class will provide a technical summary and critique prior to the start of class and engage in the in-class discussions. At least 2 weeks of this period will be used to conduct "mock" reviews of conference papers where students complete a typical conference review form (provides students with insight into the paper review process).

CLASS CANCELLATION POLICY: Class is cancelled if the instructor is more than 10 minutes late to class.

GRADING POLICY: The course is graded on the student's class participation.

- 35% attend each week and participate/engage in discussions
- **30% write** a brief summary of each paper covered (1/2 page single-spaced minimum), answering:
  - What did the authors do (technical contribution)?
  - What are the strengths / weaknesses / potential improvements?

Summaries should be submitted via box in the folder for the week with a filename: userID.pdf

Summaries are due **15 minutes before the beginning of the class**.

- **25% lead the discussion** (including a presentation of the paper), depending on the number of students, at least twice during the semester. You may select a paper either from the suggested list developed at the beginning of the semester or you may find one yourself and have it approved by the instructor; all students will be asked to submit at least 2 papers to the list for review. Either way, you should notify the instructor and get approval of the paper at least one week before your presentation. (Note: A paper summary is not required for the week that you lead the discussion.)
- **10% participate** in the group paper reviews by:
  - $\circ \quad \text{Helping with presentation} \\$
  - $\circ \quad \text{Lead the discussion} \quad$
  - Provide critique
  - Complete paper review form

Grades will be based on the following percentages:

- A 90 and above
- B 80 to 89
- C 70 to 79
- F 69 and below

## ATTENDANCE POLICY:

- 1. According to the university's hybrid process, the university will assign students a day of the week they are to come this class; on other days, they must attend online.
