The CompTIA Linux+ with Command Line Profession

Linux is an open-source, UNIX-like operating system created by Linus Torvalds that runs a plethora of different devices today. When you do your online banking or use Google, Facebook or Twitter, you're talking to Linux servers in the cloud. In fact, nearly all supercomputers and cloud servers run Linux, as does your Android smartphone and many other devices around your home and workplace, such as firewalls and routers. Even your touch-screen refrigerator, home media center, smart thermostat and incar GPS run Linux.

The CompTIA Linux+ with Command Line Program

This program introduces students to the competencies required of an early career IT professional supporting Linux systems. The content provides thorough coverage of command-line skills that work on multiple distributions and prepares anyone who wants to acquire in-depth knowledge of common Linux tasks. In addition to topics traditionally associated with systems administration tasks, such as configuring, managing, operating and troubleshooting in a Linux environment, this program also focuses on security, kernel modules, storage and virtualization, enterprise-level device management, DevOps basics, through Git and automation. The program further walks through networking and firewalls, especially involving security issues, server-side and command line, troubleshooting and SELinux with a focus on implementation.

Finally, the program address the Linux Command Line Interface (CLI), which is a powerful tool for users, developers, and administrators. Quick changes to a system with no Graphical Interface, such as many servers or some recovery tasks, can be accomplished with command line tools. Repetitive tasks, such as file management and local access control changes, can be done more efficiently from the command line than through a point-and-click interface. Learning to use the Linux CLI also prepares for full automation with scripting tools.

Education and National Certifications

• Students should have or be pursuing a high school diploma or GED.

- Students who complete this program can sit for the **CompTIA Linux+ (LX0-103 and LX0-104) exam** or the Linux Professional Institute Certification (LPIC) Level 1 Certification Exam (Exams 101 and 102).
 - Successful completion of both LPIC-1 exams (101 and 102) is required to obtain the LPIC level 1 certification. The topics for these exams have been updated recently, with the latest version released in February 2015. This version of the exam introduces new topics such as databases and email server basics.
 - These exams are also offered as CompTIA's Linux+ certification. Linux+ has been "powered by LPI" (the Linux Professional Institute) since 2010, with the CompTIA and LPI exams being taken from the same pool of LPI questions. This partnership allows you to take the same exam through CompTIA under the LX0-103 and LX0-104 names to obtain Linux+ certification. Passing either LPIC level 1 or Linux+ will also earn you a SUSE Certified Linux Administrator certification, if you want to claim it.
