

Bound Copies of Your Clemson ETD: Check your order status or place an order after your manuscript has been submitted and accepted

The Graduate School *does not require* that you purchase any bound copies of your manuscript; however, your department may require that you do so. Check the list at <https://www.clemson.edu/graduate/students/theses-and-dissertations/boundcopies.html> to see if you're required to order a bound copy. Also, as noted at this link, a few programs specify a printer other than ProQuest. There are print-on-demand businesses that specialize in theses and dissertations, and you, as copyright holder, can have your work printed and bound by a company of your choosing at any time (see the end of this document).

ProQuest's ETD portal does not permit authors or administrators to change bound ETD copy order details during the period after you have uploaded your PDF, but before your manuscript has been electronically published. **If you did not place a bound copy order when you first submitted your ETD, you will need to wait until ProQuest has e-published your manuscript to place your order.** Also, please note that the time required for ProQuest to produce and ship bound copies has been affected by the ongoing COVID-19 pandemic.

There are several ways to order printed, bound copies through ProQuest after your manuscript has been published.


1. Once you've received confirmation from ProQuest that electronic publication of your work is complete (*this may be a couple of months after your graduation*), you may place an order for copies through your **ProQuest upload account**. To order online and receive an author discount, click the “Order Copies” button on your submission details page (it's highlighted in yellow in [Screenshot 1](#). on the next page). This button is active *before* you submit, becomes view-only once your ETD is accepted, and becomes active once again *after* your paper has been digitally published.
2. After your ETD has been published electronically, another option is to visit **ProQuest's Support Center**, at <https://support.proquest.com/submitcase>. At top right on that page (shown in [Screenshot 2](#). on page 3), you may opt to use Chat or Phone. If you decide to use the form, log in using the same credentials you used to upload your manuscript. Best choices for the first three menu items are shown in the screenshot. Then enter your info, Clemson University as the library/company, and a brief message that you'd like to order a bound copy or copies, but that you didn't do so when you submitted your paper. Under “Relevant URL,” paste in the URL of your ProQuest account (the address in your menu bar when you are on your ETD Details landing page). A customer service representative will get back to you via email. You can also use the Support Center portal to request a **change of shipping address**.
3. Last, ProQuest provides a printable [2019-2020 Dissertation Order Form PDF](#). Mailing address and FAX number are on the form.

Screenshot 1. Your personal account ordering page can be accessed from the left-side menu, and looks like this. As noted above, you can place an order before you submit your PDF for the first time, or after your ETD has been digitally published. The order function is locked during the time in between these events.

The Graduate School does not offer recommendations or endorsements of third-party printing companies, but with an online search you will find reputable print-on-demand businesses that specialize in printing ETDs as single copies or in small numbers at reasonable cost (try searching **thesis printing** or **dissertation printing**). A good recommendation might also come from a published faculty member in your department.
