

## TeachingForward Fellows

AY 2019-2020  
Call for Applications



The Clemson Office of Teaching Effectiveness and Innovation (OTEI), together with the Division of Undergraduate Studies and the Clemson Thinks<sup>2</sup> (CT<sup>2</sup>) Program, announce a call for applications for TeachingForward Fellows for the 2019-2020 academic year.

We anticipate having four to five Fellows to provide academic leadership in meeting ClemsonForward REAL goals. Fellows will support the aims of ClemsonForward through:

- Advancing teaching practices related to courses in the general education curriculum.
- Fostering evidence-based teaching and student academic engagement.
- Advancing the work of OTEI and CT<sup>2</sup> to support teaching excellence.
- Supporting interdisciplinary education.

Each Fellow will develop a portfolio of programs and projects based upon his/her interests and the teaching-related needs of the faculty and University, while working closely with OTEI and the Division of Undergraduate Studies. This may include working on the transparency in teaching and learning (TILT) project, performing education development with Colleges, working with departments on course design, consulting with colleagues on scholarship of teaching and learning projects, facilitating service-learning pedagogies, etc.

### Eligibility:

- Clemson Faculty (tenured or tenure-track), Lecturer (all levels), visiting Faculty
- At least three years of teaching experience at Clemson
- Approval of Department Chair or Dean
- Demonstrated leadership with curriculum design or development (preferred)
- Demonstrated excellence in u'grad teaching and/or issues related to u'grad education (preferred)

**Appointment duration:** July 1, 2019 to June 30, 2020 (with option to renew)

**Compensation:** Each Fellow will be provided resources necessary to complete the work. This could involve re-assigned time (i.e. – course buy-out or other time release), professional development funding, and/or summer salary. The final compensation plan will be worked out in consultation with the Department Chair.

### Application Requirements & Submission:

1. Please provide a statement of interest. You may wish to detail experience and leadership in any of the following (limit to 2 pages):
  - Professional development (on-campus events such as CT<sup>2</sup> Faculty Institute, Clemson Faculty Learning Community and conferences, Global Learning Institute, etc. or off-campus events)
  - Leadership in teaching and learning (such as CT<sup>2</sup> Fellow, Global Learning Fellow, Service-Learning Fellow)
  - Presentations at teaching conference or events
  - Collaborative curriculum development and assessment
  - Collaborative course design and/or assignment design
  - Experience with integrating University initiatives (critical thinking, global learning, diversity & inclusion) into curriculum
